### 4. FIRST AID MEASURES

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

#### **Skin Contact:**

If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

### **Eye Contact:**

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

#### Ingestion:

If swallowed, do NOT induce vomiting. Give a glass of water. Get to a doctor or hospital quickly.

#### Medical attention and special treatment:

Treat symptomatically.

## 5. FIRE FIGHTING MEASURES

#### Hazards from combustion products:

Flammable liquid. On burning will emit toxic fumes, including those of oxides of carbon.

#### Methods and materials for containment and clean up:

Shut off all possible sources of ignition. Wear protective equipment to prevent skin and eye contact. Avoid breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

### 7. HANDLING AND STORAGE

**Precautions for safe handling:** Avoid skin and eye contact and breathing in vapour. May form flammable vapour mixtures with air. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke. Vapour may travel a considerable distance to source of ignition and flash back.

**Conditions for safe storage:** Store in a well ventilated area away from foodstuffs, oxidising agents and sources of heat or ignition. Keep containers closed when not in use - check regularly for leaks.

### 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Occupational Exposure Limits:** No value assigned for this specific material by the New Zealand Occupational Safety and Health Service (OSH).

#### **Engineering controls:**

Ensure ventilation is adequate to maintain air concentrations below Exposure Standards. Vapour heavier than air - prevent concentration in hollows or sumps. DO NOT enter confined spaces where vapour may have collected. Keep containers closed when not in use.

#### **Personal Protective Equipment:**
