Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

Skin Contact:

If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water. A component of this material can be absorbed through the skin with resultant toxic effects. Seek immediate medical assistance.

Eye Contact:

If in eyes, hold eyelids apart and flush the eye continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre or a doctor, or for at least 15 minutes.

Ingestion:

Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Seek immediate medical assistance.

Medical attention and special treatment:

Treat symptomatically.

5. FIRE FIGHTING MEASURES

Hazards from combustion products:

Flammable liquid. On burning will emit toxic fumes, including those of oxides of carbon.

Keep containers cool with water spray. If safe to do so, remove containers from path of fire. Fire fighters to wear selfcontained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

7. HANDLING AND STORAGE

Precautions for safe handling: Avoid skin and eye contact and breathing in vapour, mists and aerosols. May form flammable vapour mixtures with air. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke. Flameproof equipment is necessary in all areas where this chemical is being used. Nearby equipment must be earthed. Vapour may travel a considerable distance to source of ignition and flash back.

Conditions for safe storage: Store away from sources of heat or ignition. Store away from incompatible materials described in Section 10. Store away from foodstuffs. Keep containers closed when not in use - check regularly for leaks.

WES - Ceiling (Workplace Exposure Standard - Ceiling). A concentration that should not be exceeded during any part of the working day.

`Sk' Notice - absorption through the skin may be a significant source of exposure. The exposure standard is invalidated if such contact should occur.

Ingestion: Swallowing can result in nausea, vomiting and central nervous system depression. If

the victim is showing signs of central system depression (like those of drunkeness) there is greater likelihood of the patient breathing in vomit and causing damage to the lungs. Breathing in vomit may lead to aspiration pneumonia (inflammation of the lung).

Eye contact: An eye irritant.
